Material Required for Permit

Site plan including dimensions showing the point at which the fireworks are to be discharged, the location of all buildings, tents, or other canvas structures, highways and other lines of communications, the location of the audiences, the lines behind which the audience will be restrained, the location of monitors, and the location of overhead obstructions. Include the location of the electric firing unit and all personnel.

Copy of the current Colorado Certificate of the Fireworks Display Operator or Pyrotechnic Operator.

Copy of the current Colorado Display Retailer of Fireworks License for fireworks vendor.

Copy of Bond or Certificate of Insurance in the amount of \$1,000,000, naming the Fire District as insured.

Copy of ATF Permit.

Fireworks Display Safety Plan.

Check in the amount of \$125 (City/Town Sponsored or other Public Displays may be exempt from this fee.)
